Full refunds will be issued up until March 24, 2024 - No refunds will be issued after this date unless the event is canceled.

Categories / Divisions

We reserve the right to delete, combine or separate divisions/categories based on registration as per Cheer Manitoba rules and regulations. We follow Cheer Canada age grids and divisions.

Competition Rules

The provincial competition is a Cheer Manitoba sanctioned event and follows all Cheer Manitoba competition rules. Please visit www.cheermanitoba.ca for details on rules. All Manitoba participants must be registered Cheer Manitoba members. Out of province teams that are not Cheer Manitoba members are required to provide a liability/appearance/medical release form (regardless of age). Spotters are not provided during the competition. If spotters are needed, they must be registered and provided by the program/club that requires them (free of charge). All partner stunt routines require a registered (paid) spotter. All spotters must fill out the liability/appearance/medical release forms to participate.

Warm Up/Performance

The competition follows a circuit based warm up and performance schedule. Each team will be given a designated check in time to warm up. Multiple stations will be provided to allow teams to stretch, tumble, stunt and run through their full routine prior to competing. A sprung strip is included in the warm-up circuit. Specialty routines will go through the same circuit (time limits will vary based on event schedule).

Music

All teams must submit their music to Cheer MB via dropbox link by **March 29, 2024**. Dropbox link will be provided via email upon receipt of registration and payment. Please ensure that music is labeled with the team name and their division/level. Teams are encouraged to bring back up music to the competition. All back up music should be on a device connectable with AUX cord. Teams are responsible to provide someone to cue the start of the music for their routine.

Performance Schedule

All teams/clubs will be e-mailed the performance schedule one week prior to the event. A time limit will be given for any requests for review to the performance schedule. Cheer Manitoba will do their best to make sure crossover athletes do not compete back-to-back, however this cannot be guaranteed.

Awards

All competitive teams that compete will walk away with an award. The award ceremony will take place at the end of the event schedule.

Food/Storage

Food and drink will be available for purchase for the duration of the event. You may also bring in your own food and beverages. Teams will be given a common area to store their belongings however please do not bring any valuables. Cheer Manitoba is not responsible for any lost, stolen, or misplaced items.

** Teams are expected to clean their assigned spaces at the end of the event. This has been an issue in the past. Owners/coaches: please look over these areas and ensure garbage has been picked up please.**

First Aid

Cheer Manitoba will have an athletic therapist on site equipped to take care of any medical issues. This area will be well marked at the event. Please ensure coaches and staff know where it is located in case of emergencies.

Advertising/Vendor Booths

Any teams/athletes caught distributing promotional or advertising materials that are not approved by Cheer Manitoba will be asked to leave the competition immediately. This may also include teams being disqualified from competing.
