



Privacy Policy

This privacy policy discloses the privacy practices for Cheer Manitoba. This policy applies solely to information collected by the website and will notify you of the following What type of information we collect;

- Cheer Manitoba's commitment regarding the privacy of minors;
- What personally identifiable information is collected from you through the web site, how it is used and with whom it may be shared;
- What choices are available to you regarding the use of your data;
- What security procedures are in place to protect the misuse of your information;
- How you can correct any inaccuracies in the information.

Types of Information Collected

This Privacy Policy covers personal and non-personal information collection.

Personal Information is information that is associated with your name or personal identity. Cheer Manitoba uses personal information to better understand your needs and interests and to provide you with better support and service. Once you choose to provide us with personal information, you can be assured it will be used only to support your membership relationship with Cheer Manitoba. As we take the trust you place in us seriously, Cheer Manitoba will not sell, rent, lease or share your personal information with others.

Non personal information is data about usage and service operation that is not associated with a specific personal identity. Cheer Manitoba collects and analyses non-personal information to evaluate how visitors use the Cheer Manitoba website. Non personal data collected may include the pages visited on the Cheer Manitoba website, unique URLs visited within our website, browser type and IP address. Most non personal data is collected via cookies and other analysis technologies.

Privacy of Minors

Cheer Manitoba is committed to protecting the privacy needs of minors and we encourage parents and guardians to take an active role in their children's online activities and interests. Cheer Manitoba does not knowingly collect information from minors and does not target its website to minors.



Information Collection, Use, and Sharing

We are the sole owners of the information collected on this site. We only collect and have access to information that you voluntarily give us via email or other direct contact from you.

We will use your information to respond to you regarding the reason you contacted us. We will not share your information with any third party outside of our organization, other than as necessary to fulfill your request, if applicable. Unless you ask us not to, we may contact you via email in the future to tell you about events, new opportunities, programs, cheer related communications or services, or changes to this privacy policy.

Cheer Manitoba or its related entities could merge with or be acquired by another not for profit governing organization. If such a merger or acquisition occurs, Cheer Manitoba will make every reasonable effort to notify you in the event we share with the merging or acquiring entity some or all of your personal information to continue serving you.

Your Access To and Control Over Information

Security

We take precautions to protect your information. When you submit sensitive information via the website, your information is protected both online and offline.

While we use encryption to protect sensitive information transmitted online, we also protect your information offline. Only individuals who need the information to perform a duty for Cheer Manitoba are granted access to personally identifiable information. All personally identifiable information is stored electronically in a secure location and is not stored on personal computer equipment of any Board Members of Cheer Manitoba.
