Virtual Specialty Routines

Specialty routines will be required to be filmed and submitted by January 15th, 2022. A drop box link will be provided to upload submissions. In video submissions, the full 9-mat floor must be visible. Routines will be judged by Cheer Manitoba Judging Panel. Virtual Routines will be streamed by Central Cheer as part of the Winter Riot Competition schedule. Awards/Placements will be awarded at the Awards Ceremony.

Payments

Refund policy

Full refunds will be issued <u>up until **January 4**th, **2022**</u> - no refunds will be issued after this date. Partial refunds will be given if there is an event cancellation due to health restrictions.

Categories / Divisions

Central Cheer reserves the right to delete, combine or separate divisions / categories based on registration as per Cheer Manitoba rules and regulations. Central Cheer follows Cheer Canada Age grids and Divisions.

Competition Rules

The Winter Riot competition is a Cheer Manitoba sanctioned event and follows all Cheer Manitoba competition rules. Please visit www.cheermanitoba.ca for details on rules. All Manitoba participants must be registered Cheer Manitoba Members. Out of province teams that are not Cheer Manitoba members are required to provide a liability/appearance/medical release form (regardless of age). Spotters are not provided during the competition. If spotters are needed, they must be registered and provided by the program / club that requires them (free of charge). All spotters must fill out the liability/appearance/medical release form to participate.

Warm Up / Performance

The competition follows a circuit based warm up and performance schedule. Each team will be given a designated warm up check in time. Multiple stations will be provided to allow teams to stretch, tumble, stunt and run through their full routine prior to performing. A sprung strip is included in the warm-up circuit. Specialty routines will go through the same circuit (time limits will vary based on event schedule)

Music

All teams must e-mail their music to central_cheer@hotmail.com by January 15th, 2022. Please ensure that <u>music is labeled with the team's name and their division/level</u>. Teams are encouraged to bring back up music to the competition. All back up music should be on a device connectable with Aux cord. Teams are responsible to provide someone to cue the start of the music for their routine.

Performance Schedule

All teams / clubs will be emailed the performance schedule approximately 1 week prior to the event. A time limit will be given for any requests for review to the performance schedule. Central Cheer will do their best to make sure crossover athletes do not compete back-to-back, however this cannot be guaranteed.

Awards

All competitive teams that compete will walk away with an award. The award ceremony will either be one of two options: *

- 1) Take place at the end of the event schedule.
- 2) Will be split into two different award ceremonies: middle of day and end of day.
- 3) Will be held virtually at 8pm of the same day.

Food/Storage

Food and drink will be available for purchase for the duration of the event. No outside food or drinks in the facility. Teams will be given areas to store their belongings however please do not bring any valuables and be aware that Central Cheer is not responsible for any lost, stolen, or misplaced items. Teams are expected to clean their assigned spaces at the end of the event.

Advertising / Vendor booths

Any teams / athletes caught distributing promotional or advertising materials that are not approved by Central Cheer will be asked to leave the competition immediately. This may also include teams being disqualified from competing.
